Data Storage and Usage

According to permission granted to us, your name and contact details will be entered into QE Park Baptist Church's systems, such as (but not limited to): Hubb - the Church website, the church's email system and staff computers. The church's systems are password protected and accessed only by QE Park Baptist Church staff. As a manual back-up, paper copies will be retained in a locked filing cabinet, accessed only by staff.

To enable us to provide adequate pastoral support to you and your family, the Minister may record information which may be regarded as sensitive. Personal sensitive information will be stored under a higher level of security. This information will NOT be disclosed to other persons or third parties without your consent.

Subject Access, Data Correction and Deletion

You have the right to ask to see all information we hold about you by submitting a 'Subject Access Request' to the Church Administrator. You have the right to request the correction of inaccurate information.

You also have the right to request deletion of some, or all, of the information we are storing.

Your contact details will be removed once you are no longer a church member or a regular attendee. However, in certain circumstances, for the purpose of Safeguarding, we may retain your data for longer.
